Summary of findings

Overall summary

About the service

Lytham Court Nursing Home is a residential care home providing nursing and personal care for up to 33 people, who were living with dementia. At the time of our inspection 31 people were living at the home.

People's experience of using this service and what we found.

Staff kept the building clean and tidy and maintenance checks were in place and up to date. Recent improvements to the environment were taking place with minimum disruption for the people living there. One person said, "It's nice they keep doing the place up." Recruitment procedures were in place and were thorough. One staff member said, "Everything was checked it was a good process to go through." There were sufficient staff to care for people. Safeguarding training was mandatory, staff were aware of the processes to follow should they witness any abuse. Risks were assessed in detail and monitored to ensure individuals safety and promoted their independence within a risk framework. People received their medicines safely.

The management team at Lytham Court Nursing Home had auditing systems to maintain ongoing oversight and make improvements when required. Quality assurance processes ensured people were able to give their views of the service.

Detailed findings

Background to this inspection

The inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 (the Act) as part of our regulatory functions. We checked whether the provider was meeting the legal requirements and regulations associated with the Act. We looked at the overall quality of the service and provided a rating for the service under the Care Act 2014.

As part of this inspection, we looked at the infection control and prevention measures in place. This was conducted so we can understand the preparedness of the service in preventing or managing an infection outbreak, and to identify good practice we can share with other services.

Inspection team

The inspection was carried out by 1 inspector.

Service and service type

Lytham Court Nursing Home is a 'care home'. People in care homes receive accommodation and nursing or personal care as a single package under one contractual agreement. CQC regulates both the premises and the care provided, and both were looked at during this inspection.

Registered Manager

This service is required to have a registered manager. A registered manager is a person who has registered with the Care Quality Commission (CQC) to manage the service. This means that they and the provider are legally responsible for how the service is run and for the quality and safety of the care provided.

At the time of the inspection there was a registered manager in post.

Notice of inspection

This inspection was unannounced. The inspection activity started on 21 November and ended on the 26 November 2023. We visited the service on 21 November 2023.

What we did before the inspection

We reviewed information we had received about the service since the last inspection. We sought feedback from the local authority and commissioners who work with the service. We also looked at information we had received and held on our system about the home, this included notifications sent to us by the provider and information passed to us by members of the public. The provider was not asked to complete a Provider Information Return (PIR) prior to this inspection. A PIR is information providers send us to give some key information about the service, what the service does well and improvements they plan to make. We used all this information to plan our inspection. We used all this information to plan our inspection.

During the inspection

We spoke with 4 people who lived at Lytham Court Nursing Home, 3 members of staff, and a registered nurse. In addition, we spoke with the registered manager and the operations manager. We observed staff interaction with people, and reviewed a range of records. These included care records of people who lived in the home, medication records, and 2 staff files in relation to recruitment. We also reviewed a variety of records relating to the management of the service. We had a walk around the premises and looked at infection control measures.

After the inspection

We continued to seek clarification from the registered manager to validate evidence found. We looked at their quality assurance systems the provider had in place and staff training records.

Is the service safe?

Our findings

Safe – this means we looked for evidence that people were protected from abuse and avoidable harm.

At the last inspection this key question was rated as good. At this inspection, this key question has remained the same. This meant people were safe and protected from avoidable harm.

Assessing risk, safety monitoring and management; Learning lessons when things go wrong

- The registered manager and nurses assessed risks to ensure people were kept safe. Staff took action to mitigate any identified risks.
- Staff understood people's needs and risks and knew what action to take to keep people safe, documents were dated to show risk assessments were updated and reviewed.
- Environmental risks were identified, and systems were in place to carry out regular safety related checks on essential equipment.
- Accidents and incidents were analysed. Action was taken to reduce the risk of accidents.

The Mental Capacity Act 2005 (MCA) provides a legal framework for making particular decisions on behalf of people who may lack the mental capacity to do so for themselves. The MCA requires that, as far as possible, people make their own decisions and are helped to do so when needed. When they lack mental capacity to take particular decisions, any made on their behalf must be in their best interests and as least restrictive as possible.

People can only be deprived of their liberty to receive care and treatment when this is in their best interests and legally authorised under the Mental Capacity Act (MCA). In care homes, and some hospitals, this is usually through MCA application procedures called the Deprivation of Liberty Safeguards (DoLS)

- We found the service was working within the principles of the MCA and if needed, appropriate legal authorisations were in place to deprive a person of their liberty.

Staffing and recruitment

- Staff recruitment processes were in place and followed according to their policy to ensure checks were carried out prior to staff starting work at Lytham Court Nursing Home.
- Sufficient numbers of personnel with different skills set were deployed to ensure people were cared for in a timely way. Nurses were employed 24 hours of the day to ensure people's nursing needs were met.

Using medicines safely

- Records for the receipt, administration and disposal of medicines were kept. There were written protocols to guide staff on the administration of medicines prescribed 'as and when' required. People received their medication safely by trained nurses.
- Auditing processes to monitor medicines and identify any issues were in place. Nurses were employed to administer medicines at all times of the day.

Preventing and controlling infection

- People were protected from the risk of infection as staff were following safe infection prevention and control practices.
- We were assured that the provider had processes to admit people safely to the service.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- The provider was making sure infection outbreaks could be effectively prevented or managed.
- We were assured the provider's infection prevention and control policy was up to date.

Visiting in care homes

- People were able to receive visitors without restriction, in line with best practice guidance.

Systems and processes to safeguard people from the risk of abuse

- People told us they felt safe and confident with staff that cared for them.
- There were effective safeguarding processes in place. The management team understood their responsibilities for keeping people safe and the processes for reporting any concerns.
- Written evidence of staff safeguarding training and regular updates was provided. One staff member said, "They are hot on safeguarding training, and I know the process to follow."

Is the service well-led?

Our findings

Well-Led – this means we looked for evidence that service leadership, management and governance assured high-quality, person-centred care; supported learning and innovation; and promoted an open, fair culture.

At the last inspection this key question was rated as good. At this inspection, this key question has remained the same. This meant people's outcomes were consistently good, and people's feedback confirmed this

Managers and staff being clear about their roles, and understanding quality performance, risks and regulatory requirements; Continuous learning and improving care

- The registered manager was supported by nurses and care staff who were trained and understood their responsibilities for delivering care for people. A staff member said, "We are supported and work well as a team."
- The management team had established systems for monitoring the quality and safety at Lytham Court Nursing Home and were aware of their regulatory responsibilities to other agencies.
- The registered manager was open and honest about what achievements had been accomplished. In addition, what had not worked so well and where improvements might be needed.

Promoting a positive culture that is person-centred, open, inclusive and empowering, which achieves good outcomes for people

- The management team had systems to ensure person-centred care that achieved good outcomes for people. One person said, "The manager is wonderful and always around which is nice."
- People's individuality was respected, and they were encouraged and helped to maintain their abilities and follow their own ambitions and way of life choices wherever possible.

How the provider understands and acts on the duty of candour, which is their legal responsibility to be open and honest with people when something goes wrong

- The registered manager encouraged candour through openness. The management team and staff were clear about their roles, and understanding of quality performance, risks and requirements working in a care setting.
- It was evident if any complaints were made, they would be listened to, and their concerns and worries would be investigated a new system had been introduced to enhance this.

Engaging and involving people using the service, the public and staff, fully considering their equality characteristics

- People and families felt involved in their care and development of the service at Lytham Court Nursing Home. They were able to give their views about the service through satisfaction surveys and regular formal and informal meetings.
- The management team held staff meetings for the exchanging of views and ideas. One staff member said, "We have a great manager who is open and approachable."
- Planned audits from senior management took place on a regular basis. These included medication, care planning, and infection control. The registered manager attended the provider's regional management

meetings and clinical meetings, where good practice was shared and any issues dealt with.

Working in partnership with others

- Records showed the management team sought advice and guidance when needed from health and social care professionals.
- The management team worked with other agencies and relatives to share good practice and enhance good nursing care at Lytham Court Nursing Home.
