Summary of findings

Overall summary

Defoe Court is a care home for 41 people who require nursing or personal care, set over two floors. Some people who use the service are living with dementia. The home is situated in its own grounds with an enclosed garden area. There were 40 people using the service at the time of our assurance visit.

We found the following examples of good practice

All staff, contractors and visitors used appropriate personal protective equipment (PPE).

The home had sufficient supplies of appropriate PPE which was stored hygienically. Alcohol gel stations were accessible around the home. There were designated hand washing stations for staff.

Staff followed national guidance about putting on, taking off and disposing of PPE safely.

Staff supported people's social and emotional wellbeing. Activity bubbles had been formed for people to take part in regular activities.

The senior staff explained the quality systems they had in place to check the service was providing safe care. Systems and processes were closely monitored by the manager and the infection control leads.

Cleaning schedules were in place for all areas of the home and records of cleaning were completed.

All staff, including catering and housekeeping staff had undertaken training in infection prevention and control. This included putting on and taking off PPE, hand hygiene and other Covid-19 related training.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.
