## Summary of findings

### Overall summary

#### About the service

Eothen Residential Homes – Whitley Bay is a 'care home'. Eothen provides accommodation for up to 35 people who require support with personal care, some of whom are living with dementia. 33 people were using the service at the time of the inspection.

We found the following examples of good practice:

- Staff had worked additional hours to ensure the service did not have to rely on agency staff during the coronavirus outbreak. Staffing levels were safe and staff were well supported by senior leaders.
- All visitors had to undergo a temperature check and answer a range of relevant questions before leaving the reception area. There was ample PPE and handwashing facilities available, along with clear signage prior at the entrance and throughout.
- The provider demonstrated a sound understanding of current national guidance and the winter plan; they had plans in place for socially distanced visiting when guidance allowed.
- People kept in touch with their relatives via telephone and videophone, whilst the activities co-ordinator and staff spent additional one to one time with people, as people could not take part in group activities at the time of inspection.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 (the Act) as part of our regulatory functions. We checked whether the provider was meeting the legal requirements and regulations associated with the Act.
