# Summary of findings

## Overall summary

Marigold Nursing Home provides accommodation for up to 49 people who require support with nursing or personal care, some of whom are living with dementia. 48 people were using the service at the time of the inspection.

We found the following examples of good practice:

- Appropriate measures were in place at the entrance and inside the home to prevent visitors from spreading infection. All visitors had to wear appropriate personal protective equipment (PPE) and complete a health declaration.
- The environment was very clean. Additional cleaning was taking place including of frequently touched surfaces.
- National guidance was followed on the use of PPE. There was clear signage on the correct use of PPE and handwashing techniques. Staff had received appropriate infection prevention and control training and regular audits were carried out.
- Local restrictions on visiting were in place at the time of the inspection and alternative measures such as video calls were being used. Visits were arranged for people who were receiving end of life care and carefully managed to ensure risks were kept to a minimum. The registered manager communicated regularly with family members about their relative's health and to keep them up to date on the latest visiting guidance.
- The provider and registered manager ensured staff were fully supported to maintain their wellbeing. The registered manager kept up to date with the latest guidance and ensured this was communicated to staff.

## **Detailed findings**

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.
