Summary of findings

Overall summary

The Bungalow provides single-storey accommodation for up to 19 older people in the Farnworth area of Bolton. On the day of the inspection there were 19 people using the service.

We found the following examples of good practice.

The service had contacted relatives and friends and discussed visiting arrangements. Visitors were to be limited to one per household and a booking system was to be in place to allow for cleaning between visits. An area had been identified for visits, which had a separate entrance. Visitors would not have to access any part of the home other than the visiting area. There were facilities for visitors to sanitize their hands on entering and leaving the premises.

All staff only worked at this one care setting reducing the risk of any spread of infection. No employees in the clinically extremely vulnerable group worked at the home currently. Staff wore appropriate PPE around the home. Arrangements were in place for staff to socially distance on breaks. Signage for PPE usage and hand washing were visible around the home.

Whole home testing was carried out at the service, in line with requirements. The service ensured people had been tested prior to admission. People newly admitted to the service were isolated for 14 days and retested as per current guidance. There was an up to date and appropriate IPC policy in place.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.
