Summary of findings

Overall summary

Victoria Care Home is a residential care home registered to provide personal and nursing care to up to 53. The home supports people aged 65 and over, some of whom were living with dementia. The home is divided into two units with one unit on the ground floor and one unit on the first floor.

We found the following examples of good practice:

- Staff did not move between the ground and first floor units to minimise the risk of transmission.
- There were designated personal protective equipment (PPE) donning and doffing areas at the home. Staff donned and doffed PPE in line with guidance and staff were wearing PPE correctly during the inspection.
- Clinical waste was managed safely and in line with the national guidance. Staff also carried out additional cleaning in the areas through which clinical waste was removed from the building.
- The home had a regular testing programme in place. New staff were tested before they started to work at the home to ensure they did not have COVID-19.
- Cleaning schedules at the home had been reviewed and enhanced. This included regular cleaning of frequently touched surfaces throughout the day.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of coronavirus, we are conducting reviews to ensure that the Infection Prevention and Control practice was safe and the service was compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place.

This inspection took place on 12 November 2020 and was unannounced.
