Summary of findings

Overall summary

Clayton House provides accommodation and personal care for up to 19 people. At the time of our inspection there were 18 people living at home, some of who were living with dementia.

We found the following examples of good practice

People we spoke with said they were happy with the care and support they received. One person said, "They do everything they can to keep us safe and my room clean."

People were supported to maintain contact with people who were important to them. There was a variety of options in place to support visiting and people being able to access their community.

Processes were in place to support visitors to access the building safely. This included proof that visiting professionals and contractors had been vaccinated and had received a negative LFD test before entering the building. Staff and people received regular tests in line government guidance.

Process were in place to ensure additional cleaning was undertaken to reduce the risk of the spread of infection. Infection control audits were completed regularly to ensure any actions required were identified and addressed. The service was clean, tidy and odour free.

Staff wore their PPE correctly and had received infection control training.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 17 February 2022 and was announced. We gave the service 24 hours' notice of the inspection.

Our findings

Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
