Summary of findings

Overall summary

About the service: Ashurst Residential and Care Home is a care home providing personal care for up to 19 older people and younger adults some of whom may be living with mental health. At the time of the inspection, 16 people were using the service.

We found the following examples of good practice.

People followed government guidance when entering and leaving their home and when receiving visitors.

Staff had received training in Infection Prevention and Control and understood the requirements for the use of personal protective equipment to keep everyone safe.

The home was well maintained, and a programme of works were in place to manage the environment. For example, an upstairs toilet room was planned for refurbishment to ensure it remained suitable and safe for people to use.

People had risk assessments to support them to live safely under COVID-19.

Staff and people were tested regularly for COVID-19. Evidence of completion of the required vaccinations was maintained for staff.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 17 February 2022 and was unannounced.

Our findings

Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.

We have also signposted the provider to resources to develop their approach.

- The providers approach to visiting was in line with government guidance. People were supported to access the community for example with visits to the local hairdressers. People were supported to maintain contact with their loved ones with the option of outside visits in a purposed outbuilding.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

- The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
