Summary of findings

Overall summary

Elderthorpe Residential Home is a 28-bed service and is registered to provide accommodation and personal care for people. At the time of the inspection there were 25 people using the service.

We found the following examples of good practice.

The registered manager has facilitated visits for people during the pandemic, inclusive of remote video calls and safely managed onsite visits.

Professional visitors and relatives were tested for COVID-19 before visits took place. Visiting professionals were also asked to provide evidence of their vaccination status prior to entering.

Staff and people living at the home completed regular COVID-19 testing, and had received their COVID-19 vaccinations.

Staff had received additional training during the pandemic in the correct use of Personal Protective Equipment (PPE) and infection prevention and control. Staff were observed to be wearing PPE correctly and had access to this throughout the service.

The home was clean, well ventilated, with robust cleaning schedules in place.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 24 February 2022 and was announced. We gave the service 24 hours' notice of the inspection.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- The provider was facilitating visits for people living in the home in accordance with the current guidance.

Visiting in care homes

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The Government has announced its intention to change the legal requirement for vaccination in care homes, but the service was meeting the current requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
